# YELLOW FLOWER GLUTINOUS RICE



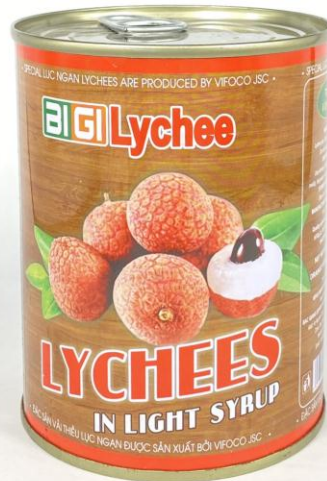

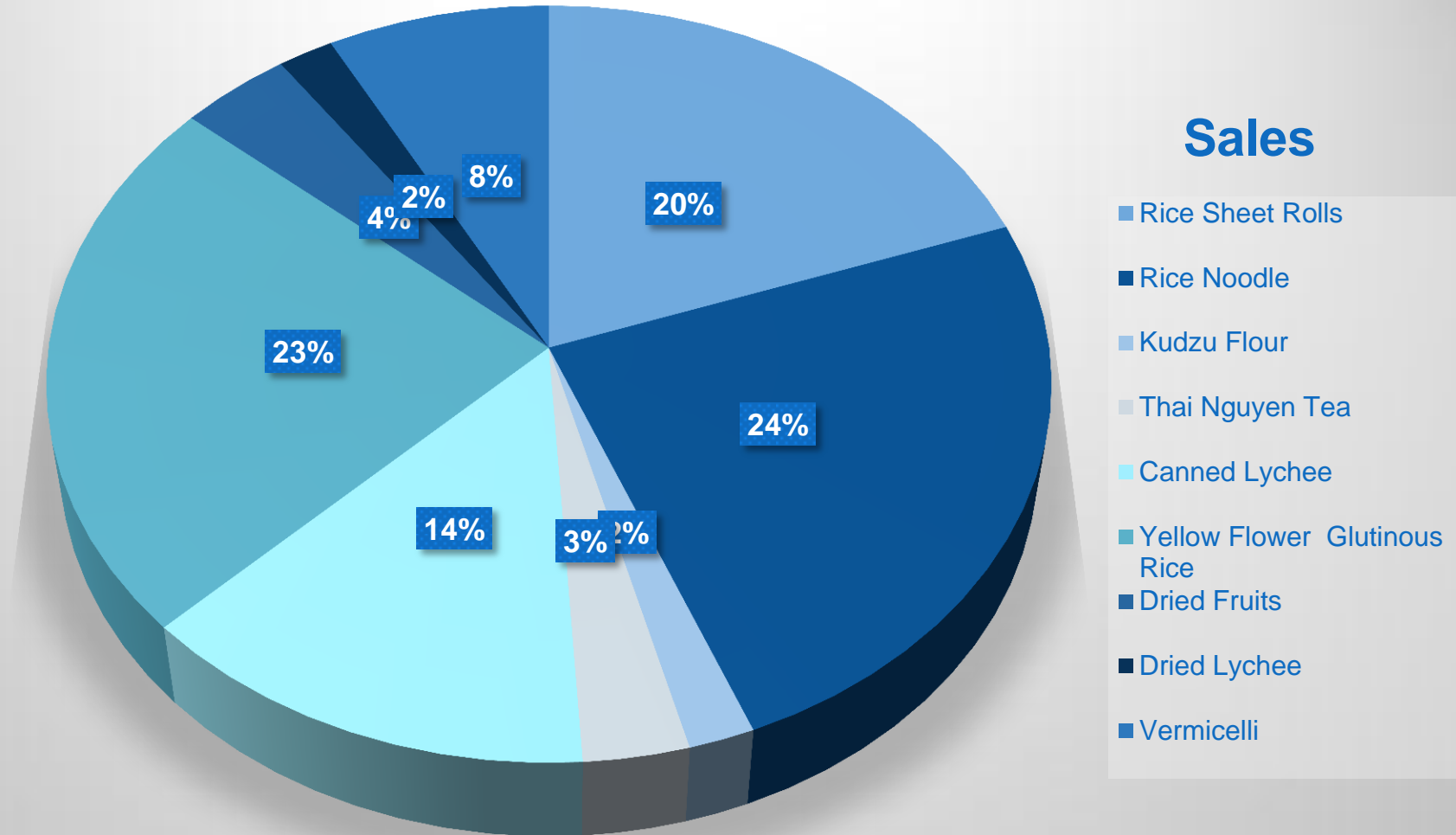
