DETERMINE STANDARDS AND REQUIREMENTS:

DETERMINE QUALITY STANDARDS AND TECHNICAL REQUIREMENTS OF EXPORT MARKETS.
ENSURE PRODUCTS MEET ALL REGULATORY SAFETY AND ENVIRONMENTAL STANDARDS.
CHOOSE TEST METHOD:

DETERMINE APPROPRIATE TESTING METHODS BASED ON PRODUCT TYPE AND MARKET REQUIREMENTS. CONSIDER RANDOM TESTING AND FULL PRODUCT TESTING.

PREPARE TEST SAMPLE:

TAKE A REPRESENTATIVE PRODUCT SAMPLE FROM THE SHIPMENT FOR INSPECTION.
ENSURE THAT THE SAMPLE IS TAKEN RANDOMLY AND IS REPRESENTATIVE OF THE ENTIRE LOT.

OUALITY CHECK AND TECHNICAL REGULATIONS:

CHECK THE QUALITY OF THE PRODUCT BASED ON PREVIOUSLY DETERMINED CRITERIA.
COMPARE PRODUCTS WITH ESTABLISHED TECHNICAL REGULATIONS AND SPECIFICATIONS.
CHECK PACKAGING AND LABELING:

CHECK PACKAGING TO ENSURE SAFETY DURING TRANSPORTATION.

CHECK THE LABEL TO ENSURE THE INFORMATION IS COMPLETE, ACCURATE AND COMPLIES WITH LEGAL REQUIREMENTS.

CHECK QUANTITY AND WEIGHT:

CHECK THE QUANTITY OF PRODUCTS IN THE SHIPMENT TO ENSURE IT MATCHES INFORMATION ON THE INVOICE AND OTHER DOCUMENTS.
CHECK WEIGHT TO ENSURE COMPLIANCE WITH CARGO WEIGHT REGULATIONS









PACKAGING INSPECTION AND RISK ASSESSMENT:

CHECK THE PRODUCT FOR DAMAGE AND ASSESS PRODUCT SAFETY RISKS DURING TRANSPORTATION.

DETERMINE WHETHER ADDITIONAL INSURANCE OR OTHER PROTECTION IS NEEDED.
PREPARE INSPECTION REPORT:

GENERATE DETAILED REPORTS OF INSPECTION RESULTS, INCLUDING ISSUES DISCOVERED AND CORRECTIVE ACTIONS.

KEEP RECORDS TO TRACK DEVELOPMENTS AND MANAGE QUALITY.

CONFIRMATION OF COMPLIANCE:

CONFIRM THAT THE PRODUCT MEETS ALL EXPORT MARKET REQUIREMENTS AND STANDARDS.
PREPARE ALL NECESSARY DOCUMENTS AND CERTIFICATIONS.

MONITOR AND ADJUST:

PERFORM CONTINUOUS MONITORING TO ENSURE THAT PRODUCTS MAINTAIN QUALITY THROUGHOUT THE EXPORT PROCESS.
ADJUST THE TESTING PROCESS IF THERE ARE ANY CHANGES IN PRODUCT OR MARKET REQUIREMENTS.
